Considerations for 2019 Community Recommendations

- ▶ Priorities based on CARB Board direction (September 2018)
 - 2018 community air monitoring plans → community emissions reduction programs*
 - * *If supported by community steering committee and data*
 - Communities recommended in 2018, but not selected
- ▶ Lessons learned
- ▶ Ongoing support for 2018 communities
- ▶ State Budget maintains the same level of funding in this fiscal year
- ▶ Add no more than about 3 new communities

2019 Community Nominations

- ▶ Received about 12 nominations for individual or combined communities
- ▶ Air districts recommended:
 - Northern Corridor (Northern Imperial Valley/Salton Sea)
 - South Natomas or Del Paso Heights-Norwood-Old North Sacramento
 - Portside Environmental Justice Neighborhoods (San Diego)
 - International Border (San Ysidro, Otay Mesa)
 - Arvin/Lamont
 - Southwest Stockton
 - Eastern Coachella Valley
 - South East Los Angeles
- ▶ To ensure successful development and implementation, CARB staff is recommending a limited number of 2019 communities

Draft 2019 Community Recommendations- Existing Monitoring Community

Portside Environmental Justice Neighborhoods Community

- ▶ Transition to development and implementation of a community emissions reduction program
- ▶ Consistent with CARB Board direction
- ▶ Supported by community steering committee

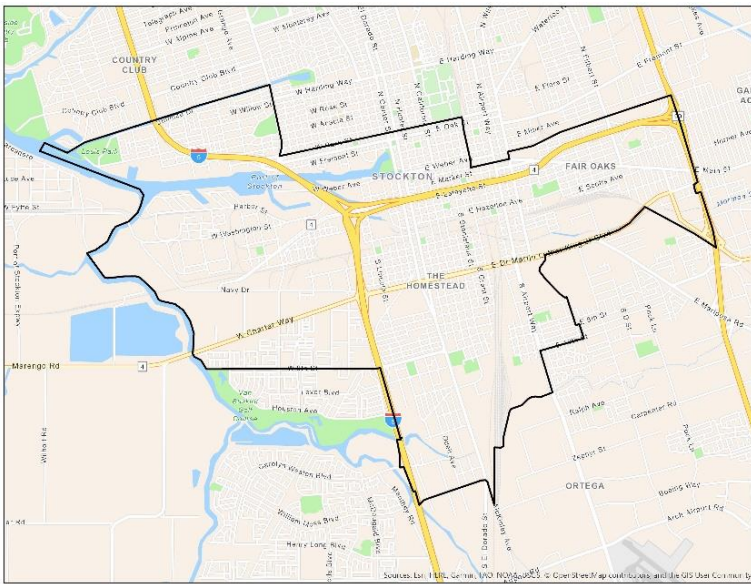

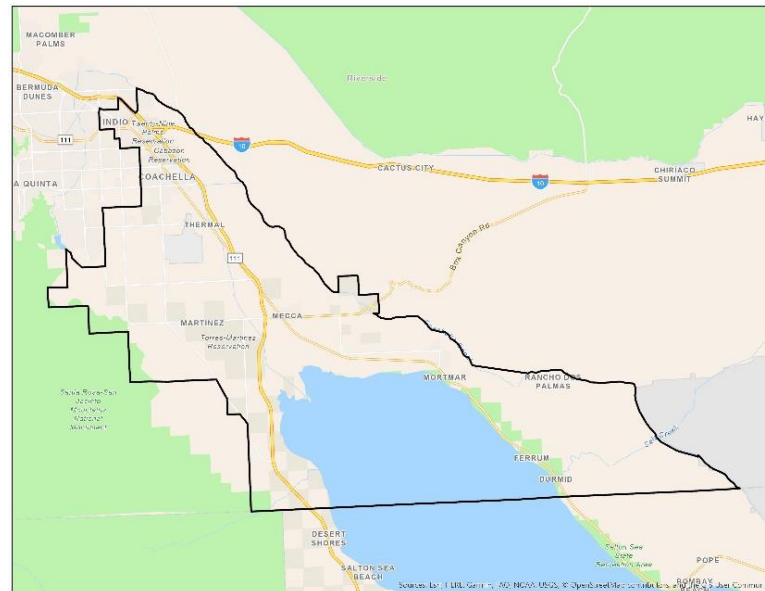
- ▶ Both community air monitoring plan and community emissions reduction program

Preliminary Boundaries for 2019 Recommended Communities

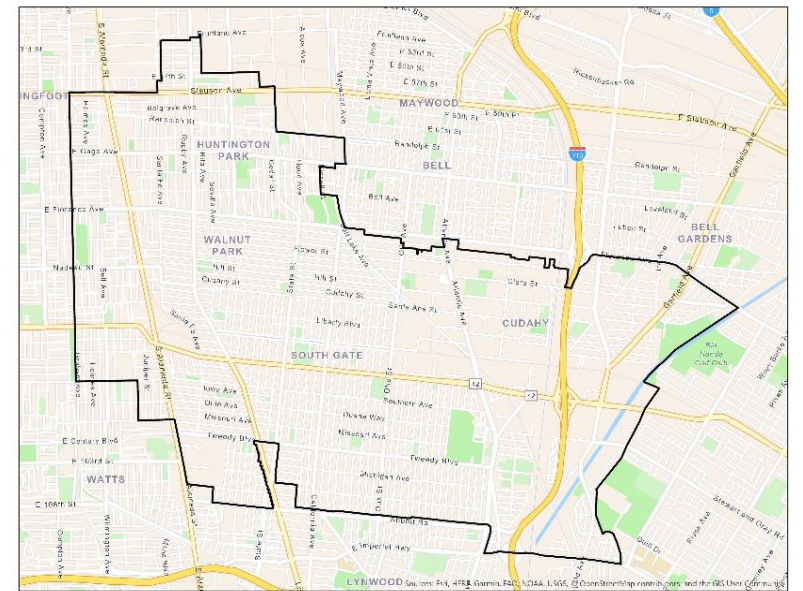
Southwest Stockton
