Public Workshops to Discuss Potential Amendments to the Regulation for Certification of Vapor Recovery Systems for Cargo Tanks

The California Air Resources Board (CARB) invites you to participate in a series of public workshops to discuss potential amendments to the fee CARB assesses for the certification of vapor recovery systems for cargo tanks (Title 17, California Code of Regulations, § 94014). The workshops are open to the public and full participation by all parties is encouraged. BACKGROUND

On April 18, 1977, the Board first approved performance standards for controlling emissions from cargo tanks used to transfer gasoline from loading racks. From 1977 to 1996, the California Highway Patrol initially implemented the certification program. In 1996, CARB took full responsibility of the implementation of the Cargo Tank Vapor Recovery (CTVR) Program. At the time that CARB took over the implementation, a \$20.00 fee was established, which has not been adjusted to reflect changes in the consumer price index or certification program needs over the last 22 years.

POTENTIAL AMENDMENTS

Staff is considering proposing to amend the California Code of Regulations to allow the program costs to be recovered, and to allow appropriate fee adjustments to be made over time. The adjustments would be made using a formula that considers the true cost of implementing the program, including factors such as California Consumer Price Index (CA CPI), as published by the California Department of Finance, costs that are attributable directly to the statewide CTVR Program, and a percentage of the indirect Board and statewide costs as agreed to by the Department of Finance and the U.S. Environmental Protection Agency, under the Code of Federal Regulations, Title 2, Part 200. Staff anticipates going to the Board to consider this item in April of 2019. The staff presentation for the workshops will be posted at
